

Stern Pinball's "Metallica Remastered" Pinball Sweepstakes

Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE DOES NOT IMPROVE YOUR CHANCES TO WIN.

1. **Eligibility:** The Sweepstakes is open to legal residents of the fifty (50) United States and the District of Columbia, 18 years of age or older. Employees, officers and directors of Stern Pinball Inc. ("Sponsor"), Metallica HQ ("Metallica") and/or any of their respective parents, subsidiaries and affiliates (the "Sweepstakes Entities"), advertising, promotion, or production agencies (and their respective IRS dependents, immediate family members and individuals residing in their same household) are not eligible to participate. Void where prohibited by law. All applicable federal, state and local laws apply.
2. **Promotion Period:** The Sweepstakes begins 12:00:01 a.m. Central Time ("CT") on 04/19/2025, and ends 11:59:59 p.m. CT on 06/30/2025 ("Promotion Period").
3. **How To Enter:** Entry is available by both of the following two methods during the Promotion Period:
 - a. Log-in to your account in the Stern Pinball "Insider Connected™" Platform (the "App"), and you will automatically receive one entry into the Sweepstakes. If you have not yet downloaded or created an account in the App, doing so is free and available in the iOS App Store at <https://apps.apple.com/us/app/stern-pinball-ic/id6449461651> or the Google Play Store at <https://play.google.com/store/apps/details?id=com.stern.insiderconnected.android>.
 - b. Fill out the form located at <https://r2.sternpinball.com/metsweeps> either to sign up for Stern Pinball's email list, or if you already were on that list prior to the start of the Promotion Period, to confirm your email address on that list.

Limit one (1) entry per person, per email address and per App account via each of the two methods listed above, for a total limit of two (2) entries per person, per email address and per App account. Multiple entrants are not permitted to share the same App account or email address. Any attempt by any person to obtain more than the allowed number of entries by using different or multiple email addresses, App accounts, identities, log-ins, automatic entry software, or any other method is prohibited and may result in disqualification. No copies, automated entries (including, but not limited to, entries made using any script, macro, or sweepstakes service), facsimiles, or mechanical reproductions will be accepted. In the event of a dispute over the identity of an entrant, entry will be deemed submitted by the authorized account holder of the e-mail account associated with (i) the App account used for the log-in, or (ii) the email address provided in connection with the entry. "Authorized account holder" is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address.

4. **Prize:** One (1) prize is available: A "Metallica Remastered" PREMIUM Model pinball machine. Approximate retail value of prize (including shipping): \$10,199. Winner is

Prize is non-transferable and no substitution of any prize is offered, except at the sole discretion of the Sponsor who may provide a substitute of comparable value if the advertised prize becomes unavailable. The potential winner will be notified promptly using the contact information available in their App account. No liability is assumed for any winner notification that is lost, intercepted or not received by a potential winner for any reason. Failure to respond to any winner notification within 7 days may result in disqualification and selection of an alternate winner. Each winner may be required to execute a Declaration of Eligibility, a Liability Release, and a Publicity Release (where legal) (“**Prize Claim Documents**”).
